EURHOPE Newsletter #10 – Athens, 11 March 2025

"Towards new phases: training, creativity and active citizenship"

Dear partners and supporters of the EURHOPE – EU as a Solidarity's House for Minors Out of Home project,

it is with great enthusiasm that we share with you the updates that emerged during the second transnational meeting, held on 11 March 2025 in Athens, hosted by ARSIS – Association for the Social Support of Youth.

Participants: 12 representatives from all partners, with the active presence of CUORE Srl, Centro Studi, Metacometa, ARSIS, Córdoba Acoge, HAU and INDEPCIE.

On this occasion we were able to present the complete Training Toolkit, we were able to define the last steps for the closure of WP2 and the opening of WP3, which will focus on a series of training activities aimed at increasing knowledge of the EU and good social practices and on the meeting between minors and positive adults, whose final result will be a Methodological Vademecum with the aim of providing tools for replicability of the project in other areas and periods.

During the meeting, the project website was also viewed, in order to improve its functioning and the usability of its contents.

Launch of WP3: Training, Dialogue and Creativity

Centro Studi introduced the contents of Work Package 3, dedicated to the training of trainers, discussion groups, artistic production and the valorisation of results.

Here are the main developments:

Activity 1: Training & Mentoring

Multilevel training course that will train operators and trainers on civic and relational education, with the final objective of preparing adult volunteers to support minors outside the family.

- Centro Studi and Metacometa, with the support of the other partners, will create video lessons to train local operators and trainers.
- The guidelines will be enriched with national data and translated into different languages.
- Adult training will take place in person.

Activity 2: Discussion Groups

Periodic meetings between minors outside the family and trained adults to discuss European issues, promote intergenerational exchange and stimulate critical thinking, civic participation and the construction of a common vision of Europe.

- 12 meetings planned for each country.
- Greece and Spain will carry them out weekly from May to November, excluding the summer months.
- Italy will follow the biweekly planning.
- The topics covered will resume those already developed in the previous groups.

Activity 3: Production of Podcasts, short films and theatre workshops

Workshops in which minors, supported by adults, will produce artistic content to tell their experiences and visions of Europe, stimulating public participation through culture.

- Each partner will develop artistic content with the involvement of minors.

Activity 4: Final Events

Definition and implementation of a final conference open to the public for the presentation of the results of the Project.

- The final project meeting is scheduled for May 7, 2026.
- The final conference will be held in June 2026.

The next few months will focus on executing the activities of WP3 in the best possible way, in particular on successfully managing to ensure that the training and recreational meetings are actually an opportunity for adults and young people to meet, in which dialogue and especially the **inclusion of minors** reaches the quality levels that the project aims to reach.
