Conclusion of the discussion meetings between groups of supportive adults and minors out of home

The discussion groups between minors and supportive adults held in Greece, Italy, and Spain were concluded in October, and the activities were organized by promoting an experiential learning approach to the topics addressed.

In Greece, the discussion groups coordinated by ARSIS were held in Thessaloniki, Ioannina, and Kozani.

In Italy, the discussion groups are implemented by Centro Studi Affido and Metacometa and take place across several groups in Campania, Molise, and Sicily.

In each project location, activities were carried out to promote European values, in particular equal opportunities, gender respect, freedom of expression and opinion, and environmental awareness.

The methodology used to address these topics focused on the cross-cutting involvement of minors and adults through role-playing activities and open debates.

This phase of the project will allow the discussion groups to begin developing their project work, which will be presented at the conclusion of the project.
